Edmund Rice International, on behalf of this coalition commends the participation of Canada in its 4th UPR.

We commend Canada's commitment to advancing reconciliation and renewing its relationships with First Nations, Inuit and Métis peoples, especially concerning food security and access to clean drinking water.¹

Furthermore, we remain deeply concerned about protection of the rights of some of Canada's **most vulnerable people**, in particular, **the elderly, people with disabilities and people experiencing mental illness.** While welcoming the acceptance of recommendation n. 37.279², we remain concerned by the eligibility criteria for receiving Medical Assistance in Dying (MAID) and the promotion of MAID as a more cost effective alternative to other health care options, to the detriment of the ultimate protection of Canada's most vulnerable.

This NGO Coalition calls on Canada to:

- a) adopt prompt and effective measures to ensure food security and access to clean drinking water for indigenous communities;
- b) improve ease of access, funding and staffing for Long Term Care Facilities in order to provide adequate assistance to the elderly, including quality palliative care;
- c) ensure adequate and meaningful participation of people with disabilities, as well their representative organizations, in drafting laws, policies and regulations that affect their rights, particularly with regard to MAID.
- d) update the eligibility criteria for MAID to ensure protection of the most vulnerable, including the removal of mental illness as one of the co-qualifying considerations for access to MAID.
